9. Update on Monce Road Sidewalks

Plans for the sidewalks were briefly discussed. Proposals in the amount of \$193,028 have been received. The town will look for a grant or possibly have public works do the work to reduce the cost. The Lake Garda association has agreed to allow public access to their hiking trails if a sidewalk is installed.

Thompson mentioned a Housing development Proposal in town that included Affordable housing, Work Force housing, Senior Housing, upscale housing and commercial components.
